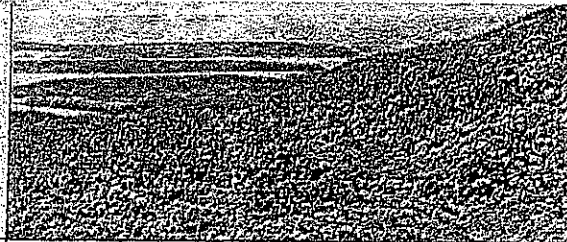

RE: Suite 101 – Authority Office Building

The LSHA Trustees previously approved the use of Suite 101 (west end of the Authority Office Building) to be used by the UF Healthy Families Support Program. The program utilizes the space to house 1 employee. This employee is mobile; therefore, they are not present in the office at all times. No lease was prepared; however, UF was required to provide insurance and indemnify the Authority.

Upon approving the use of the building by UF Healthy Families, the Authority placed a 6 month time limit on the arrangement. The 6 months will expire on October 10, 2022. **Staff is requesting that the Trustees approve the continued use of Suite 101 by the UF Healthy Families Support Program on a month-to-month arrangement.** The month-to-month request is to insure that the Authority may meet any obligations that may be required to lease LSH Campus Buildings long-term.
